It's out with the old for Longs soda fountain



John and Sandee Wilhoit are crying the soda fountain blues.

During construction of Horton Plaza mall in 1985, there was plenty of hoopla about a soda fountain being installed in the center's Longs Drugs. For nearly a quarter of a century, the soda fountain has served as a place for locals to congregate and enjoy a sundae or an ice cream cone.

Now that CVS/pharmacy has taken over Longs Drugs, the soda fountain's days are numbered. It is headed to soda fountain heaven next month when the store is remodeled.

CVS/pharmacy spokesman Mike DeAngelis said it is being

removed "to accommodate the full CVS product mix." DeAngelis said the company recognizes the attachment some customers have to the soda fountain, so a special event is planned before its removal.

Westfield Horton Plaza officials don't have any say in the matter.

"Regardless of what our personal opinions are at Westfield, we can't force someone to do something inside their store," said marketing director Rebecca Handelsman.

"What a shame," said Wilhoit, who lives in downtown San Diego. "Maybe there can be enough local resistance to change this decision."

That's not very likely, though. DeAngelis said not one store in the national CVS chain operates a soda fountain.

A hot romance
